## QUICKLY IDENTIFY PROVIDERS WHO ARE BEHIND WITH THEIR ENTRIES OR THOSE WHO ARE CONSISTENTLY HIGH PERFORMERS

## How to read the report:

- 1. **Students In Caseload:** This is the total number of students in the caseload for that month. NOTE, this number is updated once a month at the beginning of the month.
- 2. Students Eligible: These are students that appear in Black Bold on the provider's caseload.
- 3. **Students logged:** This is a count of students who had services recorded in a particular month. If a District Administrator knows that a provider should be logging on at least 8 Medicaid students and only 2 were recorded, then the administrator is cued to follow up with that provider.
- 4. **Monthly Log Count:** This tracks the number of service logs entered for student dates of service in that month.
- 5. **Total Logs Entered:** This row tracks the total service logs entered in a month regardless of when the service was delivered.

Consistency is really what is desired. Looking at Count Dracula, for the month of April, there are 15 logs entered within the proper month. Unfortunately, there were no services recorded in March if you look at the Total Logs Entered. When the total logs entered row goes up and down like a rollercoaster, then this is a provider to pay attention to and deliver friendly reminders for more consistency.

The student detail (the first three lines) all appear in one drill down. This will include detail on the total number of students on the caseload that month, the number of students who have a Medicaid number, and the count of services recorded for those students. The **Black Bold** students have a Medicaid number whereas the non-Medicaid students are in normal font. For example, the chart below shows that Elsa Frozen had two services for the month of January and a total of two services entered.
